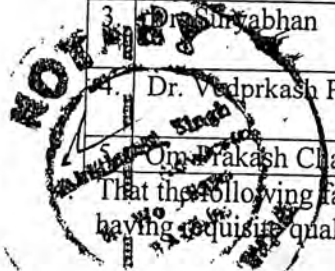
**FORMAT OF AFFIDAVIT TO BE SUBMITTED BY THE MANAGEMENT ON RS. 100/- STAMP PAPER**




